

2. The deadline for the filing of Respondents' brief and Intervenors' briefs is hereby extended until October 4, 2021.
3. The deadline for the filing of a reply brief, if any, is hereby extended until twenty-one (21) days after service of Respondents' brief.
4. Oral argument will be heard November 10, 2021, at 9:00 a.m. (Mountain Time) at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. 
