# INSTRUCTIONS ON SEARCHING THE FINAL UNIFIED DECREE

A complete paper copy of the Final Unified Decree is housed with the Snake River Basin Adjudication ("SRBA") district court, located in Twin Falls, and the Idaho Department of Water Resources ("IDWR"), located in Boise. Electronic versions of the Final Unified Decree may be found on the websites of the SRBA district court and IDWR. The electronic version of the Final Unified Decree is searchable.

Even if a water right was decreed by the SRBA district court, the decree may not be an accurate description of the water right today because the right may have been sold, split, transferred, or its elements changed in some way. Therefore, for the most current information associated with any water right number listed in the Final Unified Decree, consult IDWR.

## HOW TO SEARCH THE FINAL UNIFIED DECREE

### 1. Content of the Final Unified Decree

There are ten (10) attachments to the Final Unified Decree. An understanding of the contents of the attachments will help narrow a search of the Final Unified Decree.

Generally, most research should begin with Attachment 2. An exception to this general rule is for water rights decreed as part of this Court's orders approving the following federal reserved water agreements/consent decrees, as compiled in Attachment 4:

#### 2. Search Instructions

There are three components to a water right number: (a) the basin number; (b) the sequence number; and (c) sometimes a split suffix. For example, in water right 63-07819A, the basin number is 63, the sequence number is 07819, and the split suffix is A. (Note: not all water right numbers have split suffixes.) The Partially Decreed Water Rights in Attachment 2 are organized numerically beginning with water right number 01-00001A and ending with water right number 86-12017. Attachment 2 also contains a name index of all water rights decreed by the SRBA district court (with the exception of the partial decrees associated with the federal reserved water rights agreements/consent decrees compiled in Attachment 4). The name index is organized alphabetically by last name or entity name. In the electronic version of the Final Unified Decree there is number index which provides a link to the scanned image of the corresponding partial decree for any particular water right number.

If a water right number cannot be found in Attachment 2, review attachments 5 and 6 to determine if the water right was decreed disallowed. If a water right number appears on Attachment 5, it is possible that the water right may have been split during the course of the SRBA, with the water use decreed under a different water right number(s). To determine if this is the case, or to review the pedigree of any water right number, consult IDWR.

If a water right number cannot be found in attachments 2, 5, or 6, the water right number may have been decreed after entry of the Final Unified Decree. In order to determine if the water right was decreed after entry of the Final Unified Decree, consult IDWR.

If a water right number cannot be found in attachments 2, 5, or 6, and was not found to have been decreed after entry of the Final Unified Decree, it is still possible that the water right number and water use may be valid. In order to determine if the water right number and water use is valid, consult IDWR.

It is possible that a water right decreed by the SRBA district court and located in Attachment 2 may have been corrected after entry of the Final Unified Decree because of a clerical error in the description of the right. In order to determine if the water right was later corrected, consult IDWR.

All research of the Final Unified Decree should conclude with consultation with IDWR to determine the most current status of the water right being reviewed.
