### **MOTION TO AMEND**

The United States respectfully moves the Court to amend Administrative Order 1 ("AO1") and the Court's Standard Forms in each adjudication captioned above to modify the United States' address for service of pleadings and other documents under the Docket Sheet procedure. In SRBA AO1 § 6(e)(2)(c) and CSRBA, PRBA, CFPRBA, and BRBA AO1 § 7(e)(2)(c), the United States' address for U.S. mail is identified as:

The Court's Standard Forms each also identify an address for the United States on the pre-filled Certificate of Mailing page. *See, e.g.*, SRBA SF1 at 4 (providing the United States' address as 550 W Fort Street, MSC 033, Boise, ID 83724). The address should be amended to the United States' U.S. mail address. The relevant forms to be modified are the SRBA SF1-SF4 and Motion for Determination of Deferred De Minimis Domestic or Stock Use<sup>3</sup> and CSRBA, PRBA, CFRBA, and BRBA SF1-SF4 and SF-7.

As good cause for this request, the United States notes that after recent budgetary changes, the Environment and Natural Resources Division ("ENRD"), which represents the United States in Idaho's general stream adjudications, no longer has support staff located in Boise, Idaho to receive and process mail at the currently listed address. The new proposed address is ENRD's primary office and contains a permanent mail-processing facility, which will ensure that counsel receive adjudication mailings. Modification of AO1 and the Court's

<sup>3</sup> The SRBA Motion for Determination of Deferred *De Minimis* Domestic or Stock Water Use identifies different addresses for the United States: the U.S. Attorney's Office for the District of Idaho and the Robert F. Kennedy Department of Justice Building in Washington, D.C. The equivalent form in the remaining adjudications, SF7, lists the 550 West Fort Street address. Both addresses can be modified to the proposed address in this filing.

Standard Forms to match the Notice of Change of Address will minimize confusion as the appropriate mailing address for the United States.

Undersigned counsel has conferred with counsel for the State of Idaho and for the Idaho Department of Water Resources, who stated that they do not oppose this motion. For the foregoing reasons, the United States requests that the Court amend AO1 and the Court's Standard Forms to identify the new mailing addresses for the United States.
